2. Presentation from UNO Student Chapter, Activities & Budget

- Highlights from presentation
 - o Hollow tube truss designed in AISC/LRFD
 - o 21.5ft long, 3ft wide with 6 degree skew (← new this year)
 - o One person can carry the whole bridge
 - o They want to “beat Lincoln”
 - o Now, working on adding shims, completing testing, etc.
- Budget
 - o \$2300 total (including entry fees), \$1000 from National (leaving \$1300 to “locate”)
 - o \$850 +/- for the bridge, \$800 for hotel rooms
 - o If all the money in reserves is used, “it will take about 8 years to build it back up.”
 - o Other sources of money/fundraising?
 - At this time, they have not done any fundraising, potentially next year
- An idea from Scott Gilliland
 - o Let the Section when and where you’ll be practicing... I’m sure there are many members who would like to come see it and show their support.

3. Student Chapter funding

- \$1600 slated for Student Activities
- Last year all the Student Activities money went to UNL because UNO did not have any teams
- So far this year, \$1000 has been paid to UNL for their Concrete Canoe and Steel Bridge teams
- Motioned by Ed Prost to give the remaining \$600 of the Student Activities fund to the UNO Steel Bridge team. Seconded by Tom Marnik. All in favor? Unanimous; motion carries. Woo hoo!

4. Review/Approval of Meeting Minutes: 1/20/2005

- Discussion:
 - o Lindsay stated that the minutes, both Draft and Final copies will now be available on the web for review.
 - o Motioned by Gretchen Livingston to approve Meeting Minutes from 1/20/2005, seconded by Peggy Meyers. All in favor? Unanimous; motion carries. Again, woo hoo!

5. Budget

- John Hill sent copies of the budget current as of 3/15/2005
- Geotech’s conference was a success! YAY!
- Questions about Future City Disbursements... possible typo?
 - o Geotech budget is \$2125, but they haven’t actually paid that yet
 - o [Geotech’s budget is \\$2,125. Since the Section keeps track of Geotech’s funds, there is no need to actually “pay” the Section. Disbursements attributed to Geotech are written out of Geotech’s balance. Geotech funds have already paid for item 60F of \\$2,125 to Future City.](#)
 - o Structural budget is \$5, but they too haven’t actually paid that yet. And, isn’t the budget supposed to be \$2125? Did something get put in the wrong column?
 - o [Structural pays for items number 60A of \\$800.00, 60B of \\$295.00, 60C of \\$250.00, 60D of \\$800.00, and 60G of \\$5.00 for a total of \\$2,150. Note that Structural did not originally pay anything for Future City, but I added the \\$5.00 to round their contribution to \\$2,150.](#)
 - o [Structural needs to be “billed” for their amount, as per the minutes, but the amount will be \\$2,150. The budget that Geotech spends needs to be increased by \\$25.00 to equal the amount being contributed by](#)

[Structural \(an oversight by me\). Also, please note that Future City usually submits a bill for shipping the model, usually about \\$175.00.](#)

o [The Section has paid \\$1,483.18 to Future City.](#)

o [Note that since the submittal of the reports to the board on March 8, the items 60A through 60D have now been fully disbursed with the exception of \\$3.02 of Item 60B, as they are under budget by that amount.](#)
